

**Canine Inn
Daycare & Boarding Agreement**



This agreement shall be in force from the date signed and for all visits thereafter to The Canine Inn LLC.

I, _____, hereby certify that my dog(s):
_____ is/are in good health and have not been ill with any communicable diseases in the last 30 days; and that my dog(s) has/have current vaccinations for rabies, distemper, parvovirus, parainfluenza, hepatitis (adenovirus) and bordetella. Dogs arriving with fleas and/or ticks may be treated with Advantage™ at the Canine Inn's discretion, at my expense. I further certify that my dog(s) has/have not harmed or shown aggressive or threatening behavior towards any person or any other dog. I give authorization to the Canine Inn to speak with my veterinarian and/or their staff to confirm my dog(s) vaccination status and date of surgical alteration.

I have read and understand the following:

1. I understand that the Canine Inn, its owners, employees, officers, directors and agents will exercise due care to protect the health and safety of my dog(s) while in their care. In the event my dog becomes ill or sustains injury, I have given permission for those in charge to take whatever steps are necessary to obtain medical treatment for my dog, and I agree to pay all charges incurred. I consent to any veterinarian being retained to render care for my dog whether or not the Canine Inn can reach me or my emergency contact.
2. The Canine Inn is an open play environment and because of this there are inherent risks, which even when closely monitored, may result in the following: i) transfer of communicable illness such as, but not limited to, bordetella virus ("kennel cough"), and ii) superficial injuries such as, but not limited to, broken nails, sore pads, minor abrasions and/or cuts. I assume all risk of injury to my dog while at the Canine Inn or in transportation to any veterinarian clinic, so long as reasonable care is taken to prevent any unnecessary injury, death or loss. Also, if I request for more than one dog to be placed in the same kennel for boarding, I assume liability for any injuries they cause to each other.
3. By entering my dog in the Canine Inn daycare facility, I agree not to file any legal charges, demands, or claims against the Canine Inn for any injury, death or loss of my dog. I hereby waive and release the Canine Inn from any and all liability of any nature for any injury, death or loss of my dog resulting from their actions or from the action of my dog or any other dog while in custody of, or on the grounds or surrounding area of the Canine Inn. If a life threatening injury or death occurs, the Canine Inn will notify me immediately to receive specific instructions on how to proceed or to advise me that my dog is being taken to its veterinarian on file if that veterinarian is available for services.
4. I am solely responsible for any harm and/or damage caused by my dog(s) while my dog(s) is/are attending the Canine Inn. Costs for repairs will be my sole responsibility. I will agree to maintain personal liability insurance to cover me in the event of such an incident.
5. The Canine Inn reserves the right to refuse services or admittance to any dog.

6. Should I or my pre-approved agent fail to contact the Canine Inn within 24 hours of the arranged pick up time; my pet will be considered to be abandoned. Any expenses incurred for the transport or overnight care shall be paid by me in addition to other fees incurred for services provided by, at, or through the Canine Inn.

7. I agree that my pet(s) may be videotaped, photographed, and/or recorded while attending the Canine Inn.
